The mission and goal of all Curing Coma[®] endeavors is to promote the recovery of consciousness through early intervention and long-term support. The first tool that a Curing Coma[®] initiative requires is a comprehensive, consolidated data base of patient information. This will allow for in-depth analysis, and the ability to define and share best practice standards for care.

CURING COMA® DATABASE OBJECTIVES

- Capture data from over 100 countries
- Test hypotheses in large study samples that could never before be tested
- Understand the breadth and depth of the impact coma has on the world
- Provide quality feedback to hospitals and providers to improve care now and in the future
- Engage medical providers who want to help but do not know how
